"Why Contest?

by Eric Silverthorne, NM5M and George Perkins, N5UI, of the DFW Contest Group



The May meeting of the Collins Amateur Radio Club will be held on Tuesday, May 28th, at 5:30 pm at Woodcreek Church, 3400 E. Renner Rd., Richardson. Following a brief business meeting, a program entitled "Why Contest?" will be presented by Eric Silverthorne,

NM5M and George Perkins, N5UI, of the DFW Contest Group.

George and Eric will discuss why we contest and dispel a few myths about contesting, including that you need a BIG STATION to participate and that BIG GUNS only really care about working other big guns.

They will give an overview of the types of contests occurring nowadays and how to pick one that's best for you. And, of course, knowing which of the myriad of logging software apps is best for contesting.

George, N5UI was first licensed at the age of 15 as WN4QBW. He is interested primarily in HF, CW and contesting, although he does dabble in DMR as well as HF digital modes like FT8, etc.

Professionally, George has been in the Information Technology field for his entire career working at such OEMs as Sun Microsystems, Hewlett-Packard, and Oracle Corp. More of his background is available at https://www.linkedin.com/in/george-perkins-dfw/

Eric Silverthorn, NM5M was licensed just after his 13th birthday in September 1976 as WN5WHR and was introduced to contesting in early 1978 after participating in the ARRL Novice Roundup. He received his current call (NM5M) in 1983 after passing the Extra exam. Outside of contesting, Eric enjoys chasing DX and engaging in conversational CW at fairly high speeds.

He has been a CW instructor in the CW Academy for the past 7 years, is an active member in CW Opsa, and FOC, and is a co-founder of the DFW Contest Group. Over the years Eric has operated from the following DX locations: Eritrea, Congo DRC, 4U1ITU, China, Mexico, Antigua, and Galapagos. He enjoys participating in multi-op contesting and has operated from K5TR in Austin, NR5M in Houston and most recently K1TTT in New England.

Minutes of CARC Board of Directors Meeting

14 May 2024

President Mike Montgomery WD5TX began the informal pre-meeting workshop via Zoom at 1904.

Topics addressed are summarized below.

Purchase of Safety Harnesses for Club Antenna Work. Mike Montgomery stated that all required equipment has been purchased from Grainger and will be available this week. There are tentative plans to complete repeater antenna repair work this weekend.

Upgrade of Computers for the Club Radio Room. Mike Montgomery stated that he has upgraded the three computers provided by the Company for use by the Club. Mike replaced the installed hard drives with new solid-state drives and loaded new operating systems without Company-proprietary code. A motion to reimburse Mike will be voted at the formal Board meeting to follow.

Addition of CARC Check Request Form to Webpage. Frank Krizan will forward the current draft of this form to the Board for review and revision if needed, and he will then arrange to have it posted to the Members Only webpage.

Filing of Annual Report to State of Texas. Bill Swan reported that he has submitted the Texas Franchise Tax Public Information Report for the CARC to the State this month. This is the first such report submitted by the Club; annual resubmissions will be required. Bill will review the CARC Officers Transition Guide to ensure that guidance for this submission is current. The filing will be posted on the CARC website Members Only page.

Repository for All Club Account Information and Passwords. The Board discussed the need for a common repository to collect access credentials and a list of authorized users for all CARC accounts with external entities. At a minimum, the following accounts should be included:

HamClubOnline Zoom

Prosperity Bank QRZ.com

Texas Secretary of State Hanover Insurance

Texas State Comptroller

Jim Brown volunteered to develop a candidate methodology that will:

Capture all relevant existing records for each account as PDF files

Create a list of authorized users for each account

Create a list of active passwords for each account

Data as above will be stored on two identical portable memory devices to be retained by two current officers of the CARC.

This methodology will be reviewed at the next Board meeting prior to implementation.

Formal Board Meeting. The formal meeting was begun at 1940 to address issues as defined in the prior workshop. One motion developed in the workshop was formally offered:

I Wonder.....

I Wonder??

What will our Elmers of 2044 be advising and mentoring the newly licensed amateur radio operators on? An Elmer is defined as an individual who acts as an advisor and mentor to a newly-licensed amateur. I remember well, as I expect you do, my Elmer. Almost 67 years ago my Elmer was W5BD, Les Downing. Les lived on a farm on the outskirts of Angleton Texas, which is about 50 miles or so south of Houston. Les could copy Associated Press releases at 50+ wpm, type those releases on a manual typewriter and hold a running conversation with me all at the same time. Talk about multitasking. Amazing! Les taught me not only the rules and regulations of amateur radio and some of the technology, but he also taught me what it meant to be a good operator - lessons I hope that I will never forget. Les has long been a SK, but I remember him well. I bet you also have similar stories you could tell about your Elmer.

My Elmer was dealing with tube-based equipment, CW and AM modes and a hands-on (no computer) control of everything from the mic or key to the antenna. I bet in 2044 the Elmer will be advising and mentoring the new ham on what has been referred to as a Modio. That is short for the combination of Modem and Radio. The line between the two is hard to determine. We already see that today in equipment like the Flex radios, but by 2044 it is almost certain to be smaller, more powerful, have significantly less need for user interface to operate (think holographic and AI), and have vastly different operational characteristics. The FCC rules and regulations that the 2044 amateur will operate under will also certainly have changed from today.

Yes, the Elmer of 2044 will have a vastly different world to advise and mentor the new operator on. The Elmer of 2044 could be dealing with a box that you set on a table, speak to about who or what you want to connect to, and that is it. The box senses the environment around it, does all the calculations about distance and direction from its location to the desired location, figures out the best path to connect

the two points and determines the best means to make that connection. It could be RF, Internet, or a combination of both. Sound far-fetched? Not so, Lone Ranger. The company I worked for actually had a multiyear IR&D project built around those goals. We never achieved all of our objectives, as technology did not exist to support them at the time, but we achieved some great breakthroughs in advanced synthesizers, software-defined radios and surface acoustical wave (SAW) technology.

I have little doubt that the Elmer of 2044 will be advising and mentoring the newly-licensed ham on something not too far from this do-it-all box.

Remember the lesson from my Elmer that I hope I will never forget? That was how to be a good operator. That is one thing that will not change for the Elmer of 2044. That Elmer must instill in the new ham the understanding of what the heart of amateur radio is. And that heart is built around the three guiding words that the CARC has adopted: Education, Fellowship and Service.

The Elmer of 2044 and the Elmer of today share that responsibility.

Who are the Elmers today? They are you and me. Who are the Elmers of 2044? They are the brand-new hams who today just got their new call sign.

Excerpt from Jack, W5TFB's Book

Here is the next excerpt from Jack's book. Jack and Sue grow even closer to each other. A lot of good information about cooking, too.

Tuesday 27 November It was after 8 when I woke up. It was raining, and the sky to the east was dark. Sue was not in bed, so I dressed and went downstairs. I opened the front door and walked out on the porch to get a better view of the sky. There was a little light low to the south, a fair breeze from the north, chilly. It occurred to me that Mae would need a ride to school, not that she couldn't walk, but it was nasty out. I was sure the wind was stronger and rain more penetrating away from the house.

I was cold so I went back in the house. Sue was in the kitchen putting up the clean dishes. She asked me what I

wanted for breakfast. I got out a mug and poured coffee and said I wanted nothing.

I asked, "Where is the best place to buy shrimp? I want to make gumbo today and that's the only thing I need."

She said, "It's just across from the ice house. It used to be a filling station until we ran out of gasoline that summer. It still has the old-style pumps outside. It has a hand-painted sign that says 'The Fish Man.' The owner is always there, must be older than us, but he has the freshest seafood anywhere. He is open now."

"I could take Mae to school and go there. I also need to do laundry, including whatever you need to be washed."

"Well, the sheets and towels could be washed I guess. I'll make you a basket or two while you're gone."

"Would it be OK if I bought some fish too? I recall you had baked bass in Lafayette. If there is still some left-over chicken by the time I make the gumbo I will add that. I'll ask Mae if that would be OK with her."

Sue said, "Yes, that would be good. George will fillet the fish after you select it and give you the parts not used separately so you can make fish stock. There is never any already filleted fish there. Same thing goes for shrimp: you will have to behead them yourself. He doesn't believe in mutilating his fish."

"Great! Gumbo made with fresh fish stock is even better. I have to use chicken stock in Texas."

Mae came in, not looking hungry, only sleepy. "It is raining hard. I had the north window open and it rained in just a little. Not much. The wind is strong and cold."

Sue said, "Jack has to buy things for dinner and can drop you off at school on his way. What will you have for breakfast?"

"Nothing, just coffee. I'm still full from last night."

I said, "I think we all are. That was a wonderful treat. After school, if you have time, I hope you can tell me how you cooked the broccoli."

"Better than that, I'll show you. It would go well with gumbo it you're still going to cook that. There is plenty of broccoli in the garden. Is there any more bread? Some toast will hold me until lunch."

I was closest, got out the much-diminished loaf, and cut two slices. I was going to have to make bread, and we were out of whole wheat flour. I asked them where to buy that.

The toast popped up, and I served Mae one slice. She said, "If you are going to get fish from George, just continue down to the docks and follow that road. On the right about a kilometer from the docks there is a Whole Foods like store except local and a little less expensive. They have organic whole wheat flour in bulk. I noticed we are low on yeast too."

I thanked her, and asked Sue if she would like to split the other toast. She would so we did. When Mae finished eating, she said it's 830 so we should go.

Sue walked us through the office to the parking lot where I was parked. The rain was cold. It was so windy an umbrella would be useless, but the car wasn't far. In the car, I asked Mae about the leftover chicken. She said, "There is just the dark meat. You probably like it, but we don't much. You could use the meat for the gumbo and the carcass for stock."

Then Mae asked me when I was going back to Texas. I told her I had some medical things I had to do early next week so I would go back Sunday. I said I don't know how long it will take. We arrived at the school and she told me I could just let her out in the street instead of waiting in line to save her ten seconds of rain.

I continued to the docks and found the 'natural' food store just where Mae said it was. I got twenty pounds of flour, half a pound of bulk bread yeast, and whole wheat pasta flour, went back to The Fish Man and got two pounds of shrimp. There was a pretty red snapper, so I got that, filleted. The Fish Man didn't look old in spirit, but he was wall-to-wall wrinkles. I asked him if he ever fished, and he said he used to, for a living, out of Biloxi MS. He asked if I wanted the stuff he cut away for stock and I said I did. "Times have changed," he said. "Folks usually say they don't want the bones or other parts."

I just nodded and thanked him. The rain had let up enough so that I could see pretty well. Sue must have seen me in the driveway because she met me at the office door. We took the stuff to the kitchen and I showed her the snapper. She asked if I could make Salsa Snapper, and I said sure. "As you saw, we could split a fillet for lunch and still have three for dinner with the gumbo. One of them is a little bigger than the others. It would make a nice lunch with a salad from the seemingly unlimited garden. It is just as easy to make a quart of picante as a cup. It keeps forever with all the acid from the tomatoes and vinegar. Do you think you would use some if there were, say, a pint in the icebox?"

"Yes. Sometimes I mix it with grated cheddar and microwave it until the cheese melts, then eat it with a spoon. I have actually eaten the Salsa, straight up, from the jar."

"How decadent."

"Good word, just perfect for the task. That sounds fine for lunch. I have a poncho that would fit you (or almost anyone over 5 feet tall) if you want to go to the garden now." I said, "Let me do laundry first. I'm sure you have some, and I was going to wash the sheets and pillow cases in both rooms in addition to my stuff. There is probably some from the kitchen too. I'll leave the basket next to your closet door. After the last laundry I didn't give you back your basket, so I still have it."

"My side isn't locked. I already stripped the bed and gave you stuff to wash. It's in a basket by your bed. Marie does all her own laundry and takes care of her room."

I put the fish and shrimp in the icebox and went to do chores. Everything fit in one basket. One of the machines was free so I started the load.

I didn't know where Sue was, so I assumed she was in her office working, or out somewhere. I got the mixer and went to work on the bread. Perhaps this should be some kind of mystical experience, but actually it was automatic and required no thought.

I wondered why Mae had asked me about going back to Texas. The only thing I could come up with is she is worried that I won't come back, which is a possibility if I am too sick. This caused me to wonder why again, too deep I know, and it must be because she wants Sue and me to be together. It can't be that she likes me, for I am really nothing to her except a new friend. Well, I was on her side in this one. I wanted Sue and me to be together forever. I sort of asked her. I didn't ask her long ago and have regretted it until now.

While the bread was doing its thing, I found a large enameled pot on the icebox which would be perfect for the gumbo. Just to make sure I looked for and found the okra, and returned with four quarts. There was some canola oil, so I put a pint of that in the pot on the hottest burner, added a pint of flour, and cooked it on high, stirring frequently with a wooden spoon. Meanwhile I chopped onion and celery, and opened the okra to make sure it was good. I was using whole wheat flour so you can't go by the color, but smell is a better indicator anyway.

When the dark roux was ready, I turned the heat to medium, added two T butter, the onion and celery, and heated the okra in the microwave. When the onion and celery had nearly melted, I added the okra and stirred everything, adding hot stock to keep it thick but easy to stir. (After this it is almost certain that the roux will not disunite, but it is still better to not drastically lower the temperature.) Then I covered it and turned the heat to low. It would cook for hours just like it was. The stock looked like it was reduced to a quarter so I covered it and set to simmer.

It was getting close to time for lunch, so I got a small Corningware dish, cut the larger of the snapper fillets in half and placed on the buttered dish skin side down, spooned the salsa over, and set aside. I turned the lower electric oven to 450° , and went out for lettuce. There was some tender romaine, and I selected that.

Back inside, I put some olive oil in the wooden salad bowl, added crushed garlic and salt, and rubbed that around. I washed and tore the lettuce and dried it on paper towels. I thought last night's salad was elegant and complicated but for lunch all we needed was a simple olive oil, vinegar, and egg dressing. I did use balsamic vinegar, a vinegar made

from white grapes, the finest cured in wooden casks in which red wine had been aged. It is sweet and would be good for the tender young lettuce. I found a cheese grater loaded with Parma cheese in the freezer.

Just in time, Sue arrived. I said, "Lunch in 20 minutes, or say when. Twenty minutes is good. I'll be down in ten." I put the fish in the oven. I went out and found that the laundry was dry, so I brought it in, took it upstairs to my room. Back to the kitchen, I punched the bread down and got out two large plates for the food. To her you are a deity, someone sent from afar to fix everything. I have to admit you have played your part, just by accident. Happenstance would be a better word."

"Lunch is ready." I brought plates with fish and the salad bowl to the kitchen table, made the dressing at the table, and sat. I said, "I can possibly add to this complex relationship. Mae said she had overheard you say I was good for her. Mae said, verbatim, 'I don't think it is for me. You treated Craig the same as me. "Sounds good. I put on clean sheets after you took the others to wash." I turned down the fire under the gumbo, covered it, and let her lead me there once again.

Mae was doing homework at a desk in the library. It looked like math, except upside down. Sue didn't seem to care if we were seen. In her room, we undressed and crawled between the clean sheets. It was so wonderful to hold her! We started out with smoochy kisses, but she turned over and we spooned. It was nice. When we do this, she usually has her head on my shoulder. I was going to have to keep track of time and be downstairs by 1640. This was an ideal setting for falling sound asleep. I guess I didn't think this thing through, but holding Sue was something I needed, probably we both did.

I looked back at the clock and saw 1635, so I got up, went through the closet passage, and dressed in the newly clean clothes. As I passed the library, I noticed Mae was not at that desk. Downstairs I found her at the chess board, but I didn't think I had time to see what she was studying. I noticed she was writing in a notebook. Called her to have dinner soon.

Not a good feeling, but I knew holding her would fix it. I know it is bad tactics, but I told her: "Darling, I need you tonight like never before." The 'darling' just came out. I had never addressed anyone as darling before. I hoped she would understand it was affection.


